WHEREAS, Estuari is desirous of having the dates set forth in the original license amended so that Estuari has a full year's use of the licensed premises, from July 15, 2016 to July 14, 2017, with an option for a second full year, from July 15, 2017 to July 14, 2018 if written notice of intention to exercise such option be given to the IDA on or before March 14, 2017; now, therefore be it

**RESOLVED,** that the Chairman of the IDA is hereby authorized to execute an amended license agreement in favor of the Licensee, with the amendments set forth above, subject to approval thereof as to form by Agency Counsel.
