**Public Comment Period:** The Chairman opened the floor for comments from the public. There were no comments.

**Minutes Of the Previous Meeting:** M. Della Rocco made a motion to accept the minutes as written. D. Baldrey seconded the motion, which was approved unanimously.

**Budget Report:** The budget report for the month of December 2016 was presented by J. Lozano. After a brief discussion, R. Bounds motioned to approve the budget report. C. Henninger seconded the motion, which was approved unanimously.

**Director's Report**: R. Pasinella discussed the progress of the population health initiative he has been working on. Mr. Pasinella noted that the Mr. Avella was no longer under contract with ITM and his services are still needed to move the initiative forward. **Preliminary SEQR Resolution – Regeneron Mill Creek Project:** J. Clinton introduced a Resolution Directing the Executive Director Of Rensselaer County Industrial Development Agency To Take Certain Actions Under Article 8 Of the

Environmental Conservation Law In Connection With A Proposed Project To Be Undertaken For The Benefit of Regeneron Pharmaceuticals, Inc. Project. After a brief discussion, C. Henninger made a motion to approve the resolution. J. Church seconded the motion, which was approved unanimously.

Ron Bounds noted that Michael Della Rocco received the New York Farm Bureau Distinquished Service To Agriculture Award at a ceremony held in December. The board members congratulated Mr. Della Rocco on receiving the award.
