RESOLUTION AUTHORIZING GRANT OF LICENSE TO NYSTEC TO OCCUPY AND USE CERTAIN SPACE IN THE QUACKENBUSH BUILDING

WHEREAS, the Rensselaer County Industrial Development Agency (the IDA) has obtained a lease on the Third Floor of the Quackenbush Building in Troy, NY for the purpose of subleasing or licensing portions thereof to start-up companies or other small enterprises in order to encourage the development of new businesses and industries in Rensselaer County; and

WHEREAS, NYSTEC is interested in obtaining a license from the IDA to occupy and use approximately 2797 square feet of that space, known as Suite 340, should that space become available for re-licensing, for use as general office space, and for any other uses which may be agreed upon between the IDA and NYSTEC, in furtherance of NYSTEC's enterprise; and

WHEREAS, the IDA is interested in granting a License to NYSTEC to occupy said space for one year commencing on or about July 16, 2017, with an option to renew for a second year, at a monthly License Fee of \$3,729.33 for the initial term, with a two percent increase in the monthly fee upon renewal of the License for a second year; and with an option to pay the License Fee on an annual basis in the amount of \$43,360.00 for the initial term and in the amount of \$44,052.00 for the renewal term, if any; and

WHEREAS, the granting of a license to NYSTEC upon the aforesaid terms and conditions would be in furtherance of the purpose, goals, and objectives of the IDA; now therefore be it

RESOLVED, that the Chairman of the IDA is hereby authorized to execute a license agreement with respect to Suite 340, should that space become available for re-licensing, in favor of NYSTEC, upon the terms set forth above and upon such other terms as are commonly incorporated in License Agreements granted by the IDA to Licensees in the Quackenbush Building, subject to approval thereof as to form by Agency Counsel.
