IDA Meeting -11/8/18 Public Comments Period

Comments by: Lee Cookson-Resident of EG

- 1. Here to oppose additional 16 million tax forgiveness to Regeneron:
 - At least 5 have been granted so far
 - Giving away million of EG real estate revenue
 - Regeneron rising PILOTS are paying a small fraction of total real estate tax value-EG taxpayer are losing that money
 - Regeneron is fastest growing company in USA.
- 2. I've asked for proof from IDA that benefits from PILOTS have positive impact & Mr. Pasinella doesn't seem to have that proof. Here's some of what they've given me:
 - PILOT Payments-but no accounting of lost tax revenue based on full accessed value of each property each year
 - IDA & County owe EG nothing-Don't tell me about PILOT payment-to offset increased expenses for Regeneron presence in our community
 - 30% employees live in county
 - Can't tell us # live in EG...WHY?
 - "We know all that has occurred, but can't definitively say that's because of Regeneron" Why Not? Dig Deeper otherwise IDA has no proof that benefits claimed are real.
- 3. You the Board are accountable to the people-like me, not to Pasinella, IDA staff, County or State:
 - Our last line of defense again poor spending of yours & our money
 - We need you to have the courage to ask Pasinella & IDA staff to give you solid, verifiable proof that benefits they are claiming are real and until they do then you are bound to say no to their request until they "show you the beef"
 - Given that the State Controller's office is beginning to take a look at PILOTS state wide because of complaints. If so, they take a look at this IDA & maybe Regeneron PILOT, I think each of you should want to make absolutely sure the necessary proof is there if you approve this abatement of 16 million.
 - Remember responsibility to prove what they contend is Pasinella & his staff, not yours, not mine, not EG's, but once you approve then it's your burden to be able to substantiate why you approved and granted the request.
 - You are the jury here & just like you are serving on a jury, if you are going to convict someone you want to see proof of guilt.
