WHEREAS, SelfArray, Inc. has previously been granted individual licenses from the Agency to occupy and use approximately 398 square feet of space in the Quackenbush Building, known as Suite 360, and approximately 333 square feet of space in the Quackenbush Building, known as Suite 370, for use as general office space for Evident Technologies and SelfArray, Inc., and for any other uses which may be agreed upon between the Agency and SelfArray, Inc. in furtherance of its business; and

WHEREAS, SelfArray, Inc. is desirous of renewing its licenses for both Suites, under one license, which license would extend to August 31, 2020, with renewal options, and upon substantially the same terms and conditions as set forth in the previous licenses, for a monthly license fee of \$1,109.46; and

WHEREAS, the granting of such a license upon such terms and conditions would be in furtherance of the purpose, goals, and objectives of the IDA; now therefore be it

RESOLVED, that the Chairman of the Agency is hereby authorized to execute a license agreement, as set forth above, in favor of SelfArray, Inc., upon substantially the same terms and conditions as set forth in previous licenses, for a term ending August 31, 2020, with renewal options, subject to approval thereof as to form by Agency Counsel.
