**WHEREAS**, the Troy Rehabilitation and Improvement Program (TRIP) has worked for many years to improve and increase the stock of affordable housing in the City of Troy and the County of Rensselaer; and

**WHEREAS**, the availability of quality affordable housing for workers is a key element in attracting and retaining employers in Rensselaer County; and

**WHEREAS**, the Rensselaer County Industrial Development Agency is interested in promoting development projects in and around the distressed areas of Rensselaer County communities; and

**WHEREAS**, the Annual Homecoming Dinner of TRIP and its affiliated organization, Rensselaer County Housing Resources (RCHR) provides an important opportunity for RCIDA members and staff to meet and interact with those people who are active in the improvement and expansion of the stock of affordable housing for the labor force in and around distressed areas of Rensselaer County communities; and

**WHEREAS**, pursuant to Agency policy with respect to the expenditure of Agency discretionary funds, Agency staff have reviewed this proposed expenditure utilizing the Agency's evaluation worksheet, a completed copy of which is attached hereto, and have recommended Agency participation in the event in furtherance of the Agency's mission to promote economic development and job growth in Rensselaer County, and

**WHEREAS**, the Agency members have reviewed that staff evaluation and recommendation and do concur in the recommendation and do find that participation in the event will serve to advance the core purpose and objectives of the Agency as described in Section 858 of the New York State Industrial Development Agency Act, and will be a proper expenditure of Agency funds, now therefore be it

**RESOLVED**, that the Agency will support the aforesaid event and board members and staff are authorized to attend and participate in the TRIP & RCHR 2020 Homecoming Dinner on November 16, 2020, and shall promote the programs and objectives of the Agency to those in attendance at the event, and be it further

**RESOLVED**, that the Agency is authorized to expend an amount not to exceed Two Thousand Five Hundred Dollars in connection with said support and participation.


