

**RESOLUTION AUTHORIZING PARTICIPATION IN BUSINESS
NETWORKING EVENT**

WHEREAS, the Rensselaer County Department for Youth will host an outing on Tuesday, September 15, 2020 in which many Rensselaer County developers, bankers and business-people are expected to participate; and

WHEREAS, the annual event provides a valuable opportunity for Agency Members and Agency Staff to network with developers and business-people who are in a position to foster job development in Rensselaer County through various projects; and

WHEREAS, the strengthening of staff connections with the principal commercial and industrial developers who currently or potentially operate within the County, and likewise with the bankers and business-people in the region, is a desired goal of the Agency; and

WHEREAS, participation by the Agency in this event would include *inter alia*, the following benefits:

- the opportunity to discuss in a very direct way with commercial and industrial developers, bankers and business-people the commercial and industrial opportunities in Rensselaer County
- the opportunity to promote the services and benefits available for the Rensselaer County IDA to industrial and commercial enterprises having the potential of locating or expanding in Rensselaer County
- the opportunity to establish new contacts in the region's commercial and industrial development community and the areas banking and business community; and

WHEREAS, the Executive Director has recommended Agency member and staff participation in this year's outing to be held September 15, 2020, at a cost of Twelve Hundred Dollars (\$1,200.00); and

WHEREAS, pursuant to Agency policy with respect to the expenditure of Agency discretionary funds, Agency staff have reviewed this proposed expenditure utilizing the Agency's evaluation worksheet, a completed copy of which is attached hereto, and have recommended Agency participation in the event in furtherance of the Agency's mission to promote economic development and job growth in Rensselaer County; and

WHEREAS, the Agency members have reviewed that staff evaluation and recommendation and do concur in the recommendation and do find that participation in the event will serve to advance the core purpose and objectives of the Agency as described in Section 858 of the New York State Industrial Development Agency Act, and will be a proper expenditure of Agency funds, now therefore be it

RESOLVED, that the Agency is hereby authorized to participate in the event, in an amount not to exceed Twelve Hundred Dollars.


