

**RESOLUTION AUTHORIZING PAYMENT TO TRI-CITY VALLEY CATS

**WHEREAS**, for purposes of promoting industry, commerce and job growth in Rensselaer County the Rensselaer County Industrial Development Agency has, in previous years, shared a suite for home games played by the Tri-City Valley Cats at the Joseph L. Bruno Stadium on the campus of Hudson Valley Community College; and

**WHEREAS**, the Agency has been contacted by the Valley Cats for the purpose of renewing such arrangement for the 2021 season; and

**WHEREAS**, such renewal will permit the Agency, for purposes of promoting industry, commerce and job growth in Rensselaer County, to use twelve (12) seats in Suite "D" for one-half of all home games played by the Valley Cats during the 2021 season, at a total cost of Five Thousand Five Hundred Dollars (\$5,500.00); now, therefore, be it

**RESOLVED**, that the appropriate officers of the Agency shall be and hereby are authorized to issue to the Tri-City Valley Cats payment of the sum of Five Thousand Five Hundred Dollars (\$5,500.00) for the purpose above described.


