SEQRA NOTICE OF INTENT TO SERVE AS LEAD AGENCY FOR THE
SCHODACK I-90 CORRIDOR PLAN GENERIC ENVIRONMENTAL IMPACT
STATEMENT (GEIS)

WHEREAS, with the assistance of its planning and engineering consultant, Bohler, the Rensselaer County IDA is proposing to undertake a study to evaluate the long term development potential of approximately 6,000 acres within the Route 9 corridor in the Town of Schodack; and

WHEREAS, pursuant to the provisions of 6 NYCRR Part 617, the Rensselaer County IDA intends to serve as Lead Agency for the SEQRA review of this Type 1 Action, and, in this capacity, will undertake a Generic Environmental Impact Statement (GEIS) to assess the potential significant environmental effects of future development with the corridor;

Now therefore, be it

RESOLVED, that the Rensselaer County IDA hereby declares its intention to serve as Lead Agency for the SEQRA Coordinated Review of this Type 1 Action, and will circulate the Lead Agency Notice to all Involved and Interested Agencies, who shall be given 30 days from the mailing of the Lead Agency Notice to challenge the IDA's Lead Agency designation.
