

**RESOLUTION REGARDING 2026 EMPLOYEE
COMPENSATION ADJUSTMENTS**

WHEREAS, the Rensselaer County Industrial Development Agency (the “Agency”) has heretofore established compensation levels for the various employees of the Agency; and

WHEREAS, the Agency’s Executive Director has reviewed the duties and performance of the various employees of the Agency and has considered other factors relating to the proper level of compensation for said employees, including the employees’ diligence in the performance of their duties; their dedication to the Agency’s mission; their willingness to go above and beyond the minimum required of them in carrying out their duties; and their very satisfactory level of competence, and having considered as well the current job market conditions, the current competition for good employees, the effect of inflation on the cost of living; and, the availability of Agency funds for the purpose, and in consequence thereof the Executive Director has recommended that the Agency consider adjusting said compensation for the year 2026 by an additional 5 per cent for all employees of the Agency; and

WHEREAS, the members of the Agency, acting as the Personnel Committee, have considered the recommendations of the Executive Director and have independently considered the matter, according to the criteria considered by the Executive Director, and the Committee having concurred in his recommendations; now, therefore, be it

RESOLVED, that the Members of the Agency, having heard the recommendations of the Executive Director, and of the Personnel Committee, and having given the matter independent consideration, do hereby concur with those recommendations and do hereby approve the recommended increase in compensation of 5% for all employees of the agency, for the year 2026.
